Grounds Fee: \$20 per Horse. No additional charge for schooling.

**CLASS 1 & 2- AMATEUR/OWNER WORKING HUNTER OVER FENCES**

*To be shown by an amateur owner or an amateur member of the owner's immediate family (18 years of age or older).*

*To be shown over the outside course.*

**CLASS 3 -AMATEUR/OWNER UNDER SADDLE**

*To be shown at a walk, trot, and canter. To be judged on manners, way of going, and suitability.*

**– Edith Wills DuBose Memorial Trophy Championship and Reserve –**

**CLASS 4 & 5 -OPEN WORKING HUNTER OVER FENCES**

*Open to all riders. To be shown over the outside course. May no cross enter into classes 7-9.*

**CLASS 6 -OPEN WORKING HUNTER UNDER SADDLE**

*Same as class 3.*

**- The Tanrackin Farm Perpetual Trophy Championship and Reserve -**

**CLASS 7 & 8 -HILLTOPPER HUNTER OVER FENCES**

*Open to all riders; to be shown over modified fences on the outside course (no higher than 18"). May trot fences .*

**CLASS 9 -HILLTOPPER UNDER SADDLE**

*Same as class 3.*

**– The Camden Hunt Cup Trophy Championship and Reserve –**

**CLASS 10 -CAROLINAS' FOXHUNTER PERFORMANCE SERIES**

**– Jr Hilltopper Hunter –** *Qualified hunters to follow a Field Master at a walk, trot, canter, walking over a log and/or opening a gate. Judged on suitability as a junior hilltopper mount.*

**CLASS 11 -CAROLINAS' FOXHUNTER PERFORMANCE SERIES**

**– Adult Hilltopper Hunter –** *Qualified hunters to follow a Field Master at a walk, trot, canter, walking over a log and/or opening a gate. Judged on suitability as a adult hilltopper mount*

**CLASS 12- CAROLINAS' FOXHUNTER PERFORMANCE SERIES -**

**JUNIOR HUNTER –** *Qualified hunters to Follow Field Master at a walk, trot, canter/gallop, jumping, reverse of filed and/or hold hard. Fences 2'6". Judges on suitability as a junior first flight hunter.*

**CLASS 13 - CAROLINAS' FOXHUNTER PERFORMANCE SERIES - ADULT HUNTER –** *Qualified hunters to Follow Field Master at a walk, trot, canter/gallop, jumping, reverse of filed and/or hold hard. Fences 2'6". Judges on suitability as a adult first flight hunter*

**CLASS 14 -HANDY HUNTER –** *To be shown over the outside course: maybe asked to halt, back, or trot a jump.*

**CLASS 15 - THE SC CLYBURN CLASS**

*Open to hunters that have hunted 6 or more times during the current season. To be judged on general performance as a hunter with even hunting pace, manners, and way of going on the outside course.*

**– Trophy and ribbons to be awarded by this year's Masters –**

**CLASS 16 & 17 -CEC/GREEN WORKING HUNTER OVER FENCES**

*Open to horses that have not shown at this show prior to 2022 and Horses Eligible for CEC Hunter Division. Fences 2'3" in the ring.*

**CLASS 18 -CEC/GREEN WORKING HUNTER UNDER SADDLE**

*Same as class 3.*

**– Green Working Hunter Championship and Reserve –  
Max O. Bonham Memorial Trophy**

**CLASS 19 -THE CAMDEN HUNT/CEC HUNTER DERBY-**

**sponsored by The Tack Room**

*Four horses to fill; must have competed in at least two over-fences classes. Entry fee: \$60. Payout: \$100, \$60, \$40, \$20.*

**CLASS 20 -LEAD LINE** *No entry fee*

**CLASS 21 -HAZEL THOMPSON FAMILY CLASS**

*Ridden by at least 2 members of the immediate family to be shown at the walk and trot.*

**CLASS 31 & 32 SHORT/LONG STIRRUP CEC rated OVER FENCES**

*Open to all Fences 2' in the ring*

**CLASS 33 – SHORT/LONG STIRRUP CEC rated UNDER SADDLE**

*Same as Class 3*

**Short/Long Stirrup Championship and Reserve**

**CLASS 34 & 35 – CEC/CHILDREN'S/ADULT WORKING HUNTER OVER FENCES**

*Open to junior and adult amateur riders. Horses & Ponies to jump 2'3",  
To be judged on performance, manners, way of going, and suitability.*

**CLASS 36 -CEC/CHILDREN'S/ADULT WORKING HUNTER UNDER SADDLE**

*Same as class 3.*

**– Children's/Adult Hunter Championship and Reserve –  
The Jeff McMahon Trophy**

**CLASS 37 - THE CAMDEN HUNT/CEC EQUITATION MEDAL**

*Fences 2'3" in the ring*

**RULES**

1. The Camden Hunt Horse Show, The Camden Hunt, or Show Committee members shall not be responsible for any accident or damage that may occur to any animal, person, or property. The exhibitor shall hold the Committee harmless and indemnify it against any legal proceedings arising from any such accident.
2. The Committee reserves to itself the right of declining to receive any entry and to return any entrance fee, before the class is called, without being liable for compensation.
3. Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials on the part of the owner, rider or groom, shall disqualify the horse and the owner shall forfeit his entrance fee. In case of dispute, the judgment of the Committee shall be final.
4. No person will be allowed in the show ring during the time of judging, except those having duties to perform.
5. No schooling will be permitted on the outside course while the show is in progress.
6. Schooling on Saturday between 10:00 and 3:00; Sunday before show and during lunch break.
7. Horses may be asked to jog at the judges' discretion.
8. NO loose dogs on grounds.
9. Negative Coggins required.
